It would make us very happy to have you assist the Pastor, at his discretion, in the Radio Program on this coming Saturday evening, as well as to prepare the Young People and the orchestra for renditions at the services on the coming Lord's Day, and carry on in the usual manner. We trust the healing balm of God's sweet oil of love shall heal any wounds which have been made, and we assure you that it is our anticipation that our future association with you shall be one of utmost confidence in each other.

We are praying that the Lord will cause you to make a

decision toward our request in the affirmative.
