Minutes of the Official Board of Highway Mission Tabernacle, held at the Church on February 23, 1938.

Meeting was opened with prayer by Brother Herbert McKittrick.

The minutes of thelast Official Board meeting were read and approved.

Pastor W. R. Steelberg announced that he had called the meeting of the Official Board for the purpose of discussing generally the Missionary project, to wit:

- 1. What we are going to do with regard to our Brother Norman Bullock's support:
- 2. What part of our missionary vision shall embrace the Home Missionary field, as well as the foreign:
- 3. The consideration of a matter which concerns our Sister Louise Hackett and her return to Africa.

A discussion of the support of Brother Norman Bullock was entered into, and Brother Bell, the Superintendent of the Sunday School promised the sum of \$10.00 a month for this purpose, with the approval of the Sunday School.

Moved by Brother Spain, seconded by Brother McKittrick, carried, that the Official Board recommend to the Church that we guarantee the sum of \$10.00 a month toward the support of Brother Norman Bullock.

At the suggestion of Sister Steelberg, It was agreed that the Children's Church would also pledge \$5.00 a month toward the support of Brother Bullock.

Together with \$1000 pledged by Brother Overstreet's Assembly, \$5.00 by the Children's Church, and \$10.00 from the

Highway Assembly, the total amount pledged for Brother Bullock's support thus far is \$35.00.

After consideration and discussion it was moved by Brother Krause, seconded by Brother Carr, and carried, that the Official Board recommend to the Church that the Pastor and the Young People be authorized to open up an outside branch work under the direct supervision of Highway.

It was agreed that the Pastor write to Sister Minnie Baer, asking her for a budget, in order that we might have some idea of her financial need.

After discussion it was moved by Brother Bell, seconded by Brother Hollahan, and carried, that the Pastor, together with the Board of Trustees, formulate a system of a certain percentage to be set aside for Home Missionary Work.

The Pastor read portions of a letter written to our Sister Louise Hackett from Springfield, with reference to an amount of \$200 which Highway was supposed to have sent to Springfield for Sister Hackett's Landing Money in Africa, which she understood had been sent by Highway, but owing to some misunderstanding the money that was sent was used for her first three months' allowance on the field, whereupon Springfield advanced our Sister the sum of \$200.

It was unanimously agreed that Brother Steelberg, after investigation of the records of the Treasurer, write to Springfield to ascertain just how the matter stands.

Moved by Brother Krause, seconded by Brother Spain, and carried, that Sister Steelberg be given authority to use the money received from offerings in the Children's Church as she might be led of the Lord.

Brother Steelberg presented some pamphlets or booklets, strictly of a missionary nature, that had been sent to Brother Ward Loughlin, as Missionary Secretary of the Sunday School, and asked for permission to have these booklets, together with other missi onary literature, placed on a table in the back of the church under the Missionary Board, with a box for a free will offering.

Moved by Brother Spain, seconded and carried, that Brother Ward Loughlin be permitted to place these books on the table, as requested, supervised by Brother Steelberg.

On motion the meeting adjourned with prayer.
