## OFFICIAL BOARD

## HIGHWAY MISSION TABERNACLE

A meeting of the Official Board was called by the Pastor on September 15, 1943, immediately after the morning service:

Present:

Brother Bragg suggested that the Board of Deacons and Deaconnesses, together with the Ushers, should be organized so well that each visitor and stranger should be made welcome, and especially at the altar services the names and addresses of those who are saved and baptized should be procured.

Brother Bragg also suggested the need of a Library, and on Motion of Brother Elmer Day, duly seconded and carried, it was the unanimous decision of the Board that the Church Library be constructed in the Southeast Corner of the Sunday School Room.

Brother Elmer Day brought to the attention of the Board the fact that Highway had signed a contract with WPEN for the present calendar year; that there was a move underway whereby Evengelical Gospel Programs not affiliated with the Federal Counsel of the Church of Christ in America might be refused the privilege of the Air, and there was a question as to whether it would be wise for Highway to approach WPEN with the thought of getting a two-year contract.

Brother Walter Hepworth moved that WPEN be contacted and an endeavor made to secure a contract for two years, and if not, for one year. Duly seconded and carried.

Some discussion was had with reference to the construction of prayer rooms immediately under the Sunday School room. Brother Frank Simokat moved that the Church proceed with the construction of prayer rooms in the basement, leaving the details to be worked out by a committee. Seconded by Brother Lafferty and carried.

An enlargement of the orchestra was discussed, and

Brother A. Clark suggested that Brother Ashley Collis be contacted before the Trustees purchase a suzuphone or a similar instrument.

Brother Isaac Day moved that anybody who had an instrument out of repair and they desired to play in the orchestra, the Church would be willing to have the needed repairs made. Seconded by Brother Marshall, and carried.

Brother Joseph Combs moved that the Pastor write to the Fox Evangelistic party to ascertain when they can come to Highway, and we will adjust ourselves to their convenience, if possible. Duly seconded and carried.

On motion of Brother G. Marshall, the Trustees were instructed to purchase a fan, owned by Brother Lafferty, for the Church, at an approximate cost of \$69.00. The motion was seconded and carried.

On motion the meeting adjourned.
