

Meeting of the Official Board held at Highway Mission Tabernacle immediately following the Morning Worship Service on June 29, 1952.

There were present: Bros. Chas. Krause, W. Hollahan, Robert Alexander, Thomas Griffith, Elmer Day, Dursey, A. Clark, W. McAnney, O. Schmel, R. Lafferty, M. Nethery, M. Griffin, Emma Zehner and C.M. Payne.

In the absence of Brother Bragg, Brother Krause assumed the chair.

In pursuance of the meeting held on Sunday, June 22, 1952, Brother Krause asked for a financial report as to the Missionary status from the Board of Trustees.

Bro. Griffith stated that the Board of Trustees had a meeting on Tuesday evening and Bro. Elmer Day was in a position to give a report.

Bro. Day stated that with reference to support or partial-support with reference to the Brocks, the Board of Trustees after going over the finances believe that one of three general arrangements could be selected if approved by the Board:

1. Partial support of \$50. a month for the term
2. Should Sis. Betty June Shakelton return from Africa that would release \$60 a month to the general missionary fund, making \$110. available
3. Reducing the Radio Revival Time Broadcast from \$250. to \$200 a month, making another \$50. available.

Bro. Day also stated that the Trustee Board felt that some money should be allocated to our own people coming out of Bible School who felt a call of God to Gospel Work, to be held in readiness.

On motion duly made, seconded and carried, it was

RESOLVED, That a letter be written to the Brocks stating that we can pledge \$50. a month as partial support in order that we might receive a reply telling us how they are presently fixed, and how the \$50. would fit in their program.

Bro. Hollahan stated he had attended a meeting in Camden relative to asking the Greater Philadelphia area cooperating and asking Jack Coe to come this way for a tent meeting, stating that Bro. Barnes, of Camden, had been elected chairman of the committee, Rev. Marinacci was secretary, and a Mr. Fuller an Assistant. The meeting is scheduled for three weeks, from September 23rd to Sept. 14th. They were desirous of ascertaining

1. Will our church cooperate in this campaign
2. How many ushers and personal workers can you supply
3. What is the membership of your church ?

After discussion it was, on motion duly made and seconded,



RESOLVED, That Bro. Hollahan be our contact man, in the absence of the Pastor, and that he be given authority to attend these committee meetings, answer the necessary questions, and if necessary offer the sum of \$25.00 in order to help in the advertising program, and all Board members who could go on Monday evening were invited to do so.

Bro. Day stated that he felt that in considering our Thanksgiving Convention we should return to the old method of having a good Evangelist and using a Sunday devoted to a special Missionary Day, as we had been doing in previous years, until recently. Return to the old lines.

Bro. Griffith stated he felt also that we should get back to our old lines.

Bro. Krause stated that while our present program was suggested by Springfield, that we, as a corporation, could consider their suggestion, but did not necessarily have to follow it. He also stated that a letter had been written to the Supt. of the Appalachian District re Sister Baehr.

After further discussion, the meeting adjourned,
