

Meeting of Official Board of Highway Mission Tabernacle held on Tuesday evening, September 30, 1952, at the Church, 8 P.M.

There were present: Rev. W. S. Bragg, Chas. Krause, M. Bogdan, R. Alexander, J. Lanham, W. Hepworth, A. Clark, S. Dursey, R. Lafferty, C. MacPherson, E. Day, O. Schmel, T. Griffith, E. Zehner, M. Nethery, M. Griffin, and C. Payne.

The meeting was opened with prayer.

Bro. Bragg read a letter from Sister Shakelton, Missionary, who is now in the States, relating to her physical condition, and one from Sister Hilda Eikner, who is also in the Homeland seeking a helper.

He further stated that he had ascertained that Bro. Raymond Brock, who is going to Nigeria, Africa, has met his qualifications, with the exception of finances.

Bro. Bragg also made a statement that Bro. Duplisee is now employed by the Far Eastern Broad Cast Corporation, which is Greek Orthodox, and is not backed by Springfield.

Bro. Bragg asked the consensus of the Board with reference to having the Eastern District Council convene at Highway for three days next June.

On motion of Brother Krause, seconded by A. Clarke, it was

RESOLVED, that Highway Mission Tabernacle extend an invitation to the Eastern District Council to hold their next District Council in June, 1953, at the Church.

Bro. Bragg read a letter from Sister Minnie Baehr, and Bro. Krause read a letter from Highway Home for the Aged relating to Sister Baehr.

After some discussion it was agreed that Bro. R. Lafferty and Bro. Bragg go to see Sis. Baehr, together with her sister, if possible, after ascertaining her condition, do the things necessary to bring this matter to a close.

Bro. Bragg stated he wished it were possible for all of the Board members to help in the Altar services on Thursdays and Sundays.

Bro. Bragg gave to the Board a short resume of some things that happened at the General Presbyters' meeting relative to the so-called Big Healing Campaigns, discussing it as a matter of principle, with no names mentioned, and said that when it comes to the swelling of the hands, visions of who is going to be at the meetings, etc., such things border on the occult and spiritism side, together with the detached way in which they leave the people, wandering, and stated they also disapproved of their financial system, as well as a discussion with regard to the new Bible that is being printed. A member stated that this new Bible is advertised in our Evangel.



On motion duly made, seconded and carried, it was agreed that Bro. Bragg write a letter to Springfield stating that we disapprove of this new Bible being advertised in the Evangel.

The meeting adjourned with prayer.
