Minutes of the Deacons' Meeting, July 12^{th} , 2005

The meeting was opened with prayer, by Marco Bustos.

The deacons reviewed the **Secretary's Report**. The name of the home where Michelle Raab is staying was corrected to "Walter Hoving." On motion by Betty Roberson, seconded by Mark Menzies, and adopted without objection, the minutes were accepted as corrected.

Betty Roberson presented the **Treasurer's Report**, which was accepted without objection on motion by Marco Bustos, seconded by Otis A. Fortenberry.

Pastor Wegner presented an update on the **Resurrection Life** church plant:

- 1. The effort is consuming cash rapidly.
 - a. All of the large windows have been sealed against the weather (\$6,000 each). To restore the original stained-glass windows would cost about \$60,000 per window. The artisan, Chandler Coleman, is looking into ways that volunteers (recruited by us) can cut down on the expense.
 - b. The next step is to redo the electrical system (\$30- 35,000, with volunteers). Then, the heating system will need to be replaced.
 - c. Pastor Wegner has been in touch with the CFO of Schindler, a member of the Scotch Plains A/G, about the possible donation of an elevator.
- 2. Although more groups of volunteers are planning to come, none are on the schedule as yet.
- 3. In the agenda (attached), Pastor Wegner listed three options for keeping the cash-flow going while we wait for the grants from Missionettes and Women's Ministries. After some discussion, the deacons agreed that getting a line of credit from the Penn-Del Loan Fund is the best option. This would require a vote of the membership. With the requirement to announce a business meeting in the bulletin at least two weeks in advance, the first opportunity to present the proposal for a vote would be Sunday, July 31st. That date, being the fifth Sunday, is scheduled as the kick-off for the Deacons' Crisis Fund offering. Otis introduced a motion, seconded by Betty Roberson and adopted without objection, to delay the kick-off of the DCF offering and call a meeting to ask the membership to approve securing a line of credit of up to \$75,000 so that the work at RLC is not interrupted. At the meeting, we will solicit pledges eligible for matching (up to \$20,000) by the district.
- 4. Highway is being asked to provide lunches and to attend work-days at RLC, with the goal of fostering a sense of ownership.

The agenda lists items related to the occupancy and maintenance of the **parsonage**, with dates as available

- 1. The Rosers have agreed to allow the Wegners use of one side of the garage and will allow Pastor Wegner to keep his tools in the basement indefinitely. The tools are mainly being used for the work at RLC.
- 2. Highway Ministries will cover the cost of utilities at the parsonage. Pastor Wegner's salary was reduced when the deacons voted to pay the cost of utilities at the parsonage. Now that he is no longer living in the parsonage, that amount will be restored to his salary.

Per the agreement with VFCC and CBC, at the end of the summer, Highway will receive an offering for the **interns**. The offering will be received on August 14th.

God's Love Chinese Church, which currently meets in Highway's chapel on Sundays, may be moving to a property that they have located in Havertown. They should know within a week.

Pastor Wegner distributed a **fall-preaching calendar** (attached). The emphasis is on the 16 core doctrines of the A/G.

Pastor Wegner has reached a verbal agreement with Frank Falatico for the **replacement of the front doors**. The new doors should be installed by the end of October.

There being no further business, following prayer by Pastor Wegner, the meeting was adjourned.

HIGHWAY MISSION TABERNACLE DEACON MEETING August 16, 2005

Present for the meeting: Pastor Wegner, Otis Fortenberry, Marco Bustos, Finney Kuruvilla, Mark Menzies and Dwayne Stanley.

Secretary's Report: The secretary's report for the previous meeting was read and accepted.

Treasurer's Report: The treasurer's report for the previous meeting was read and accepted.

Resurrection Life Church: We have borrowed \$23,000 against our line of credit so far, mostly for the removal of debris and a complete re-working of the electrical system. The board reviewed and approved a draft letter to all church adherents regarding the 20k-20k plan from the Penn-Del district that we adopted earlier. We have set the matching fund offering for September 25, 2005. We have three tentative workdays set, 9/10, 10/22 and 11/12. Bethany is giving us their old pews, light fixtures and additional furniture. We are waiting for a firm pick-up date for the items to be set. We need to start thinking about people to serve as part of the ministry team for RLC. One key ministry will be Chi Alpha at Temple University. The parsonage has been repaired and repainted.

Drama: The Billy Sunday story will be presented on the evening of September 18th.

Sectional Rally: A sectional rally is set for the second Sunday evening in September. The board recommended that we send pastor and the Rosers as delegates and keep the care group meeting that is already scheduled. The rally will have a special offering for the Chinese church and the building they are buying in Haverford. Motion adopted to send a \$1,000 offering on behalf of Highway. The Rosers will be introduced at the rally.

Membership Sunday: We need to think about identifying potential new members. We should consider setting up membership classes sometime in the future. We need to set up some sort of gathering to meet with and encourage the people who are regular attendees but not members. We should explain the importance of salvation and a Christian lifestyle and later talk about the specifics of membership for those who are interested and are saved and living a Christian lifestyle. Information on this should be put in the bulletins and on the website for those who are interested.

World Missions Summit: The summit will train people interested in Chi Alpha over new year's weekend. Pastor was contacted about attending to teach and interact with the students. The deacons believe it is a good program that we should participate in if possible.

Stanley's: Dwayne and Patrice are moving in September and are planning on resigning their posts on the deacon and ministry board as of August 31st. Motion approved to accept their resignations as of that date.

Holy Land Trip: Pastor is considering a trip to Israel in June of 2006. The deacons think that it is a good experience and should be considered.

Valley Forge: The church's old van is in poor condition. Pedro has been given the old van to use in exchange for recruiting students to come to and serve at the church. The board reviewed a proposed duties outline and approved it with some minor additions regarding maintenance, safety, etc. It is important for us to maintain communication with VFCC and make people there aware of the church and the city. Motion approved to send \$300 to Pedro's account to match that given to the CBC interns.

Promotional Materials: The internet is a key resource for us. Pastor obtained some information from a company that designs letterhead, websites, etc. Their rough estimate of cost to update our information is

\$3,500. The board is interested in obtaining more information from the company and looking into specific details and prices.

Misc.: Cory Morris is now handling yard maintenance and is working on obtaining his driver's license. The last week of August is a clean-up week from the summer camp. Let's point out to the workers that we recognize the hard work that they've done. We will need to add to our budget next year a replacement of one of the air conditioning units.

Minutes of the Deacons' Meeting, September 13^{th} , 2005

The meeting was opened with prayer, by Pastor Wegner.

The review of the **Secretary's Report** was held over to the next meeting.

Betty Roberson presented the **Treasurer's Report**, which was accepted without objection on motion by Finney Kuruvilla, seconded by Otis A. Fortenberry.

Betty Roberson reminded the group that, with the rise in gas prices, it's essential that lights be turned on only when they're needed and turned off as soon as possible. Pat Wegner suggested that there be a checklist for the person who closes the building to follow to ensure that all of the lights are turned off (and that all of the other items associated with closing the building are taken care of).

Pastor Wegner informed the group that **Pastor Rodney Tilley** is facing a fall-off in funding both because he hasn't itinerated in about 10 years and because much of his fundraising-base is in the area devastated by Hurricane Katrina. Pastor Tilley is considering leaving Philadelphia for a year to raise support. His absence would have a huge, negative impact on the Albanian Church in Philadelphia. Betty Roberson introduced a motion, seconded by Otis and adopted without objection, to contribute \$100 a month to Pastor Tilley and the Albanian church. Janna Flower asked whether or not Pastor Tilley could use a lump-sum offering now, to make up some of the shortfall. Pastor Wegner pointed out that the 20/20 offering for Resurrection Life is coming up in October and that it would difficult to present both of these needs and the need for hurricane relief simultaneously. Instead, he suggested that we invite Pastor Tilley to speak on a Thursday night so that the church can receive an offering for him.

The teams discussed the need for **assimilating and** the need to **welcome** outsiders into fellowship. Valley Forge Christian College has a Friday night ministry to the homeless and has asked Pastor Wegner whether or not those to whom they minister would be welcomed at Highway's Sunday morning service.

Pastor Wegner presented an update on the **Resurrection Life** church plant:

- 5. As can be expected, the rebuilding effort in the Gulfport state is impacting the recruitment of volunteers and the cost of materials.
- 6. We have spent about half of the line-of-credit authorized from the District Loan Fund.
- 7. The 20/20 offering (district's program to match up to \$20,000 raised by the church) has been moved to October 1st.
- 8. Resurrection Life has been chosen as a center for Convoy of Hope under its new hub paradigm.

Otis presented information on the **World Missions Touchscreen**. The Division of World Missions provides free software and a \$65 information-update subscription to allow churches to present interactive, up-tod-date information on Assemblies of God world missionaries. The fee is reasonable and the system looks good, but it doesn't allow individual churches to update information or to create their own presentations. Otis will contact the Touchscreen focal to see whether or not it's possible to run PowerPoint or web-like applications on the Touchscreen PC. In the meantime, he gave \$1,000 as a budgeting figure for obtaining a system. Candace Wegner mentioned that the church gets a monthly 3-minute Newsbreak video bundled with a video subscription that she ordered for children's ministries. The videos are appropriate for sharing on Missions Sunday.

We will have a **going-away reception** for the Stanleys following the Thursday night service. We will get a coffee-table book of Philadelphia for people to sign.

There being no further business, following prayer by Pastor Roser, the meeting was adjourned.

The deacons reviewed **Secretary's Reports** from the regular meeting on October 26th and the special meetings on November 10th and 17th. Alfredo Cabrera is on track for early release from his incarceration in March of 2006. Otto Wegner has been working with Rev. Lin Crowe and has been trying to meet with corrections officials at the facility where Alfredo is housed, to understand and plan for the implications to the church. He enlisted the deacons to think and pray about the situation. Seventy percent of the adult male population in Nicetown has been incarcerated, but we have almost no expertise in that area. Alfredo is good with his hands, and may be able to do maintenance work at Resurrection Life Church, under the supervision of Victor Barnes and Stephen Roser. If there are schoolchildren in the building, this may limit how Alfredo can be used. Alfredo will be in a half-way house when he's first released. Betty Roberson suggested that teen challenge may be able to provide housing consideration in exchange for work.

Highway and Spring Garden Academy need to put together a **board for the Academy**. Among the members, there should be a lawyer, someone with accounting skills and training, and someone with a passion for children and their interests.

Otis introduced the following motion, seconded by Betty Roberson, and adopted without objection, regarding **Pastor Wegner's compensation**.

- Whereas, section 107 of the Internal Revenue Code specifies that the amount of ministers' compensation that is designated in advance by their employing church as a housing allowance is not taxable in computing federal income taxes to the extent that it is used to pay for actual expenses incurred in owning or renting a home or apartment, and, in the case of ministers who own their home, does not exceed the fair rental value of the home; and
- Whereas, pastor Otto Wegner is compensated by Highway Tabernacle exclusively for services as a minister; and
- Whereas, Highway Tabernacle does not provide pastor Otto Wegner with a parsonage; therefore, it is
- Resolved, that the total compensation paid to pastor Otto Wegner for calendar year 2006 shall be \$65,962, of which \$24,000 is hereby designated as a housing allowance pursuant to section 107 of the Internal Revenue Code; and it is further
- Resolved, that the designation of \$24,000 of pastor Otto Wegner's annual compensation as a housing allowance also shall apply to all future years that pastor Wegner is employed by Highway Tabernacle, unless otherwise provided.

Emily and Paul Hopkins have agreed to lead the Missions Committee.

The **Annual Planning Retreat** will be held January 26 - 28, 2006. Topics to think about for discussion at the retreat include moving Sunday school to after morning worship, how to put together a team to join the Rosers in starting Resurrection Life, and where Highway is going in terms of mission and worship.

The church received an application (which has been misplaced) to use the building for a wedding on September 2, 2006, Labor Day weekend. Betty Roberson made a motion, subject to review of the application, to approve the use of the sanctuary for the wedding. The motion was seconded by Otis and adopted without objection.

Betty Roberson presented the **Treasurer's Report** for February, which was accepted without objection on motion by Otis, seconded by Mary Pendleton. Betty Roberson has engaged an accountant to audit Highway's books after tax season.

The deacons shared their impressions of the RLC planning meeting with **Bro. Rees**.

- Betty Roberson: The practical operation of Highway Tabernacle might not change much. Pastor Wegner may decide to remain in charge of Highway's board get an outsider to run the overall board.

On motion by Betty Roberson, seconded by Janna Flower and adopted without objection, the **Secretary's Report for March** was accepted.

Betty Roberson presented the **Treasurer's Report** for March, which was accepted without objection on motion by Otis, seconded by Finney Kuruvilla.

The deacons discussed the following people whom the church has been supporting.

- The Tilleys have resigned as US Missionaries, effective May 1st, and have asked their donors not to send any more contributions.
- The church has learned that **Shirley Good** is caring for family and has **put her plans to help churches in Louisiana** recover their records **on hold**. Janna Flower introduced a motion, seconded by Otis and adopted without objection, to contact Ms. Good to let her know that we will be suspending missions support for her and to ask her to keep in touch should she need support for the effort in Louisiana in the future.
- **Pedro Smith** has not been able t make it to the church because the van broke down. He has contacted the church about working here for the summer. The deacons held action on his support pending a decision on the summer.

Emily Loving was named the church's new key-custodian.

The church received a **request** for donation **from Alpha Pregnancy Services**. On motion by Betty Roberson, seconded by Janna Flower and adopted without objection, the deacons elected to send a contribution of \$50.

Mark **Menzies** and Cady **Erickson** have requested use of the church for their **wedding**. On motion by Finney Kuruvilla, seconded by Betty Roberson and adopted without objection, the deacons approved the request.

Pastor Wegner introduced the concept of a **Fred Reel Award** to honor laity who have made significant contributions to the church in the spirit of Highway's first pastor, who led Highway for 20 years without receiving a salary from the church. Examples from Highway's recent past would be Mrs. Marguerite Bullwinkle, who served the church in many capacities for over 40 years. The award would also serve as a way to recognize the contribution of the Criteses and the Barneses. Pastor Wegner issued a call to research Bro. Reel's history as we formulate the award's structure.

There were no requests for disbursements from the **Deacons' Crisis Fund**. Otis needs to get to work publicizing the fund to ensure that money comes in for crises as they arrive.

Pastor Wegner received the name of a possible **minister of music** from Billy De Santo. Pastor Wegner contacted the individual and learned his salary requirements. Betty Roberson registered a concern about taking on new staff with our finances being as close as they are now. Otis asked whether or not MAPS might be able to help. Pastor Wegner said MAPS has not been receiving applications from missionaries. Janna Flower mentioned that, at Cady Erickson's church, the responsibility for music ministry is rotated among the care groups and that people are willing to minister if it's seen as an opportunity and not a burden. The deacons also discussed the possibility of paying someone part-time, and the need to check the tendency to staff hard-to-till positions (such as music minister, Sunday school teachers, and care-group leaders) by making them paid positions.

There being no further business, following prayer by Pastor Wegner, the meeting was adjourned.
