
No one from our church requested or authorized US Direct Business Services, Federal Tax ID# 98-0492248, to list our address on your web site, www.usdirectbusiness.com, for \$479. As you're fully aware, listings like the one in question, consisting of the church's name, address and phone number, are available for free on many web search sites, and a small church like ours could not justify paying almost \$500 for a listing on a site that none of our constituents is likely to have heard of or to use to try to find us.

I have investigated this case and come up with these events:

1. US Direct contacted Highway Tabernacle about a supposed balance due for an internet listing and was connected with the church's treasurer, Ms. Helen Roberson.
2. Ms. Roberson asked who had requested the listing. US Direct replied that they did not have a record of a requestor.
3. Ms. Roberson asked US Direct to send an invoice so that we could look into the charge. US Direct sent, by US Mail and by fax, an invoice that listed Ms. Roberson as having authorized the charge, although she had given no such authorization, explicitly or implicitly.
4. US Direct continued to place bellicose, threatening calls to the church in an attempt to collect payment for a service that we neither requested, authorized, nor want.

Please close this account, stop sending dunning letters, and stop the harassing phone calls.

To Whom It May Concern:


Attached, please find correspondence between our church, Highway Tabernacle, and an organization, US Direct Business Services, which has attempted to charge us for services that we did not request.
