

July 20, 1954

Board of Trustees voted to give fifty song books to our Bro. Hallahan for a new work in New Jersey. Bro. Schmeal to see that he gets them this Sunday. These are new books that are left over from the met campaign.

Bro. Elmer Day made a motion and it was second by Bro. Dron that we send \$150.00 to sis. Van Meter as a memorial fund, rather than take up and offering in the church .

September 14, 1954

The regular meeting of the Board of Trustees was held on Tuesday night September 14, 1954 with the following members present, Bro. Allen Dron, Bro. Thomas Griffith, Bro. Elmer Day, Bro. George Ambrose, Bro. Oscar Schmeal, Bro. Charles MacPherson also Pastor Wallace Bragg. Bro. McAnney being absent.

Pastor Bragg opened the meeting with the reading of the word, and also Read us in prayer. The minutes of the previous meeting were read by Bro. MacPherson and excepted as read. Bro. Elmer Day read the treasurers report and it was accepted as read.

Bro. Bragg gave the Board of Trustees a report on the meeting that was to be held in the Met at Broad and Poplar Sts. and which has been cancelled. The Owner of the Met Mr. Toppi has refused to give Bro. Velma Gardner his deposit of \$700.00 back. The other 18 churches of the 'hila. area do not feel that this is the time to hold a campaign. The Board of Trustees decided to give Bro. Bragg a check for \$700.00 to pay Bro. Gardner, and Bro. Bragg would tell the other pastors at a meeting to be held on Wednesday, that Highway would pay \$250.00 as our share and for the other churches to reimburse us and for all checks to be mailed to Highway Mission Tabernacle.

It was also brought to the board of Trustees attention that there was a need of funds to help Bro. & Sis. Brock build a house as they are in need of one for there work which is in Africa. A motion was made by Bro. Griffith and second by Bro. Dron that we send \$400.00 to the Brocks.
