

The regular meeting of the Board of Trustees was held on Thursday January 5, 1956, with the following members present:- Bros. Elmer Day, Thos. Griffith, Chas. MacPherson, Walter McAnney and Oscar Schmiel. Absent were Bros. Dron and Ambrose.

The meeting was opened with a word of prayer by Bro. Walter McAnney.

A report of the treasure was given to us by Bro. Elmer Day and it was accepted as read with a vote of thanks to our Bro.

A motion was made by Bro. McAnney and second by Oscar Schmiel that we transfer \$500. from the general fund to the building fund.

A report was given by Bro. Schmiel who is chairman of the house committee and the needs of the Parsonage were brought to our attention. It was passed by the board that we have the outside of the Parsonage painted in the spring and to see if we could not find a larger house for the Pastor and His family.

The following committee was appointed by Bro. Thos. Griffith,

The House Committed - headed by Bro. Oscar Schmiel, Chairman together with Bros. Chas. Mac Pherson, and Bro. Walter McAnney.

It was suggested that the Secty prepare a schedule for those to count the money on Sunday morning and Sunday nights.

It was agreed that only two of the trustees remain in the room to count the money. Then two others at night who would recheck that of the morning and deposit same in the bank. (trying not to hold over more than one deposit in the safe.)

The case of Sister Roccia was discussed and Bro. Roberson was to try and have the Men's Bible Class contribute to her support. also that Bro. Roberson would write to Springfield about the situation that is involved. asking what they allocate to such a field.

A motion was made by Bro. Elmer Day as seconded by Bro. G. Ambrose that we send our Sister Roccia \$50.. for January. This amount is only temporary and is for the purpose of holding over until this the supported amount is settled. A letter is to be sent along with the check supporting this position to our Sister.

A motion was made By Bro. Elmer Day <sup>and</sup> seconded by Bro. Chas Mac Pherson that we raise the traveling expenses ( auto) of Bros. Roberson to \$50 per month, ( a raise of \$15.)

A motion was made that we send \$25 twice a year to the Eastern District Office .



Bro. Hawkes asked that he be taken off the payroll as of Jan. 12 as he is now working full time and able to support himself.

A motion was made that we loan Bro. Roberson \$250. to be paid back by him when he can, with the possible cancellation in the near future.

The following was discussed and held over until the next meeting for further discussion.

That we raise the salaries of Bro. Roberson, Bro. Waggoner, and the sexton with the possibility of \$5.. per week for the sexton and from \$5.00 or \$10.. for both Bros. Roberson, and Waggoner.
