A meeting of The Board of Trustees was held Tuesday, February 28, 1956. Those present were -Bros. Roberson, T. Griffith, C. McPherson, O Schmiel D. Ambrose, E. Day, and A. Dron

The meeting was opened by prayer by Bro. Roberson.

Report by the Treasuerer was read and accepted with a vote of thanks. The House Committee reported on an estimate which was given for the enclosure of the Nursery. This enclosure would be in the Women's Rest Room and the amount of the estimate was \$175.

A motion by A Dron andseconded by E. Day that Bro. Schmiel go ahead with the necessary arrangements for the fixing up of the Nursery. Whinteers if necessary to be used so that the price could be lowered.

Under old business;-

a motion by CMcPherson and seconded by D Ambrose, that Bro. Roberson's salary be raised \$10 per week, also that Sister Shimar' travelling expenses allowance be raised \$5. per month. This latter being for a tempory time.

A Motion was made that Sister McDowell's salaryybe raised \$10 per week

thus making a weekly salary of \$30.

Bro. Roberson made a suggestion that the pianos (three- one in the Sunday School Room and the other two in the Church) be tuned. It was then suggested that Bro. Day get in touch with Wanamker's and see if they could take care of this and that a contract with them bould be established for the periodic tuning of all the eight pianos in the building.

A motion was made by Bro. MePherson and seconded by A Dron that the building fund monies be tranferred to a saving account, bearing interest, in either the P.S.F. or The Federal Saving Fund Society, preferable the latter. This was carried by all those present except that of Bro. Griffith who opposed such a move. The reason was that he felt that such was contra. to the Manuel.

The purchase of Songbooks was brought up by Bro. Roberson and it was decided that a Committee be formed for the checks of the present books. replacing the badly damaged ones with new ones. It was suggested that the help of the Young People be obtained in the cleaning up, easuring of pencils marks etc.

At this point. Boo. Griffith reliquested the chair and that the Sectary was forced to preside. The reason for such a move on Bro. Griffith's part was that he was opposed to the complete motion.
