

A meeting of The Board of Trustees of Highway Mission Tabernacle was held on Monday evening in The Church, February 18, 1957.

Those present were Bros: Roberson Ambrose, McPherson, Griffith, Simokat, Schmiel, Day and Dron.

The meeting was opened with prayer by Bro. Roberson.

The AD's have now be placed in the year books of EBI, and The Evangel College, CBI has not as yet made any reply.

The bill of the Contractor, who did the renovating on the outside of the Church, has now been paid in full.

The House Committee, said that Sister Alexander is complaining about the ddour that is found to be in the rooms in the basement. She would like the exhaust fan, which Bro. Alexander bought, be replaced as it is not working properly. She would also like to have the chairs that are in her Department be painted.

Bro. Roberson, beleives that the Sunday School should bear the expense of the painting of these chairs, He will take this matter up with the Executive Board of The Sunday School at their next meeting.

It was suggested that the House Committee look into the ventilating situation in the basement and report their findings back to the Board.

The House Committee were authorized to use the exhaust fan which we have in storage in the basement, to replace the one which Bro. Alexander bought.

It was suggested that the House Committee take care of the providing of keys for the Ushers and Bro. Wick, Asst. Supt. of the Sunday School. for the opening of the doors in the Church.

It was moved by Bro. McPherson and seconded by Bro. Ambrose that the House Committee have the locks of the doors of the Church and also the combination on the safe in the Trustees Room be changed. That the keys which are already out be recalled and new ones be reissued only to those who should have them.

It was suggested that Bro. Griffith install new lights under the balcony, like those now in the rear of the Church, eights lights in all and the cost to be about \$200.

Bro. Griffith told us that the Saving Fund where our Building Fund is place would let us borrow up to 90% of what we now have in there, Also that we could obtain the mortgage for the new parsonage from them.

Bro. Roberson presented some of the facts on a place which He found which would be suitable for a parsonage. This place is located in Brinkwood Manor, Abington.

A motion was made by Bro. Dron and seconded by Bro. Simokat that the Treasurer be authorized to draw a check in the amount of \$500. as a retained for the purchase of a property, which would meet, as our Pastor felt, the needs of a parsonage. This property to be located in Brinkwood Manor Development, Abington.

A resolution is to be presented to the Church as a special meeting which is to be called by our Pastor, for the sale of the present parsonage and the purchase of a new one.

Our Treasurer was authorized to draw a check for the purchasing of the racks, for caats now located in the Sunday School Room.

The meeting was close with prayer by Bro. McPherson.
