

A meeting of The Board of Trustees was held on May 20, 1957, in the Church.

Those present were Bros. Roberson, Schmiel, Simokat, Mc Pherson, Ambrose, Griffith, Day and Dron.

The meeting was opened with prayer by Bro. Day.

The House Committee reported progress. As to the installation of a telephone in the Sexton's house, Bro. Day is going to contact the Telephone Co.

Bro. Simokat is trying to contact the Roofing Contractor in regards to the repairing of the Church roof.

A proposal was made to have the Men's Fellowship do the painting of the Nursery.

Bro. Roberson conveyed Bro. Wells of EBI thanks for the use of the Sunday School Room for the Evening Bible School sessions.

It was suggested that we give to the Ministers Old Age Pension Fund \$200, also that a special drive be made the 2nd Sunday in June for this.

A Report on the new Parsonage was made. Mr Ziegler is taking care of the necessary papers for the mortgage of both properties. The mortgage will be for \$18700, and if at the time of settlement the old parsonage is sold then this mortgage will be reduced, ie, a new one would be prepared for 15 years with the privilege of retiring after 5 years. The approximate cost for the carrying of this will be about \$110. a month. The settlement date has been moved up to June 7th and the place to be The Frankford Trust, 4400 Frankford Ave.

Bro. Roberson made mention that the new Assembly at Souderton is in need of chairs. It was suggested that Bro. Day contact the Lansdale Assembly in regards to some chairs which we lent to them about 6 years ago. But before doing this the minutes are to be referred to to ascertain whether we lent or gave them. It was moved by Bro. McPherson and seconded by Bro. Ambrose, that Bro. Serry be contacted in regards to the price of 50 new chairs, which could replace those now used by the Orchestra. These old chairs then could be given to the Lansdale Assembly.

A motion was made by Bro. McPherson and seconded by Bro. Ambrose, that the adding machine be purchased.

Regarding the PA system the House Committee were instructed to have the small amplifying set overhauled and be put in working order to the coming street meetings (Bro. Doakes to be contacted in this matter)

Bro. Roberson was instructed to obtain an estimated further cost for screens for the new parsonage.

Bro. Schmiel requested that the Church (ie the Trustees) take over the buying of the papers called "Action (of the NAE) This request was granted and a motion was made by Bro. Schmiel and seconded by Bro. Roberson that the Church be billed and the Church be responsible for these papers. The delivery to continue being made to Bro. Schmiel's house (36 copies per quarter)

It was moved that an additional of \$75 be given to Bro. Ambrose for the moving of some more shabby.

It was suggested that a definite plan be formulated for the moving of the Church and be presented to the complete Official Board.

The meeting was closed by prayer.
