

May 6, 1963

The regular meeting of the Board of Trustees was held on Monday May 6th, 1963, with all members present. The meeting opened with Bro. Thomas Griffith reading from the word of God. Bro. Dron then lead in a word of prayer. The minutes of the previous meeting wee read by the Secretary Chas. MacPherson and were accepted as read. Bro. Dron then read the treasurers report and it was accepted as read with a note of thanks to our Bro. for the fine job he has done.

Bro. Ambrose then gave a report of the House Committee. There was some discussion about having a slot cut in the door of the 18th and Springarden Sts entrance. It had already been passed at the last Board meeting to have it done. Pastor Roberson made a suggestion that as our heaviest mail is our quarterly supplies from Springfield, our Sunday School superintendent should be contacted. To see if it could be picked up at the 19th and Poplar Sts post ofice. Or to have it sent to someones home. Bro. Ambrose said that if no one else would volunteer to pick up or have the mail sent to their home, he would have it sent to his home and bring it down to church.

The question of the rubber matting for the balcony came up, and Pastor Roberson had an estimate from Frank P. Davis of 1829 Brandywine St. The price of \$405.00 to put 24 in. brown corrugated rubber in the balcony. Also \$715.00 to do the two flights of stairs and three landings, together with the two lower treads located in the rear of the church. Bro. Ambrose also had an estimate from Sears and Roebuck & Co. After some discussion it was decided to have Bro. Roberson check with a linoleum factory in Germantown on some of their prices. Bro. Heintz is to check with his boss at work also. Bro. Ambrose is to get another new estimate. All are to repot back in one week, as men in the church have decided to do the work.

A motion was made by Bro. MacPherson and seconded by Bro. Heintz to have Bro. Ambrose take care of the loose bricks on Brandywine St. and also to fix the curbing on 18th St. Bro. Roberson then read a letter he had received from Andy Larrimore asking help for a Pastor Rev. Herbert Worrell who had lost everything in a fire in his home which was completely burned out. Bro. Roberson had made an announcement from the pulpit and had received \$93.00 by Bro. Dron and sent at once to Pastor Worrell.

Bro. George Griffin brought up the matter of parking on Thursday nights on the lot and have Highway pay the cost of the parking. Bro. Dron made a motion and it was seconded by Bro. Griffin to have the matter looked into and report back at the next meeting.

There was also a request from the sexton about hand fans. Pastor Roberson is to call Mulligans Funeral Home. Bro. Dron and Bro. Griffith are to look into the matter.

Pastor Roberson then brought to the attention of the Board that he would like to have his vacation starting on Monday June 24th, and would be gone for about four Sundays as he is driving out to Seattle Washington to see his son.

A motion was made by Bro. Griffith and seconded by Bro. MacPherson to give \$ 50.00 to the Choir to help defray expense of the Choir Banquet.
