The station is a 5000 watt station 1570 on the dial, the time 9.30 am to 10.00 am on Sunday morning. Cost of \$34.00 a half hour program. Motion carried.

A motion was made by Bro. Dron and seconded by Thomas Griffith that we have a brass railing with a curtain put around the speakers platform in the main auditoruim. Pastor Roberson and Bro. Schmiel seem to think we have enough brass rail and curtain left to do the job. House Committee to see that job is done.
