

Monday May 2, 1966

The regular meeting of the Board of Trustees was held on Monday May 2, 1966 with all members present.

The meeting was opened with Bro. MacPherson reading the 14th Psalm from the word of God. Bro. Fred Heintz lead us to the Throne of Grace for Gods Blessing on the meeting and for the prayer requests that were made.

The minutes of the previous meeting were read by the secretary Bro. MacPherson and were accepted as read.

The report of the finances of the church were given by the treasurer Bro. Allen Dron and were accepted as read, with a note of thanks to our Bro. Dron.

A motion was made by Bro. Dron and seconded by Bro. MacPherson that we go ahead with plans to install 3 air conditioners in the Sunday School rooms and one in the Sunday School office. Bro. MacPherson to draft a letter to be given to Bro. Thomas Griffith to purchase the air conditioners. Motion carried.

A report of the House Committee was given by Bro. Thomas Griffith and Bro. Frank Ostry as to the needs of the church such as having the cellar cleaned,, baptismal pool leaks in drainage system, lack of water in mens rest room, also the smell, and a partition to be put up between the urnials. Leak in the heater which is showing up on the water gauge.

Bro. George Ambrose brought up the matter of putting a ramp between the church and the Educational Building. After a little discussion it was decided to include it in with the floor plans so it would all come under one bill.

A motion was made by Bro. Dron and seconded by Bro. Frank Ostry that we purchase 3 - 3 speed record players for the sum of \$24.95 a piece. One for the Nursery, Toddlers and Sunbeam classes. Motion was carried.

A motion was made by Bro. Dron and seconded by Bro. Griffith that we purchase from Springfield the necessary books for Sister Ruth Muir and her childrens work. Books to cost around \$18.00 dollars. Also to set up a \$25.00 dollar Petty Cash so Sister Muir can buy little odds and ends which she may need for different story hour work. MISSONETT

A motion was made by Bro. Thomas Griffith and seconded by Bro. Heintz that we have a certified appaiser come in and go over the contents of the church so we would have a record of what we have for insurance purposes. Appraisal not to exceed \$150.00 dollars. Motion carried.

A motion was made by Bro. Dron and seconded by Bro. Griffith that we pay the sum of \$54.00 dollars to the Mertz Bus. Co. for taken the Choir to the Eastern District meeting. The Choir was invited to sing there and it would be hard to have them all there at one time if they took their own cars. Motion carried.

A motion to adjourn was made by Bro. John Gerhart and seconded by Bro. Frank Ostry. The meeting was closed with prayer by Pastor Roberson.
