

Monday September 19, 1966

The regular meeting of the Board of Trustees was held on Monday September 19, 1966 with all members present except Bro. Allen Dron. Bro. MacPherson opened the meeting by reading from the Bible the 147th Psalm. Pastor Roberson then led us in prayer for God's Blessing on the meeting and the prayer requests that were made.

Pastor Roberson introduced a Miss Jacqui Mullen to the Board members. Jacqui is a representative of Frank G. Pickell Associates Inc. ( Communications Counseling). Miss Mullen was at our meeting in reference to buying time on radio station W K D N of Camden New Jersey. The time to be 10- to 10.30 am on Sunday morning. The price \$65.00 dollars for a half hour program to be heard on AM and Fm stations at the same time. A motion was made by Thomas Griffith and seconded by Fred Heintz that we accept station W K D N for one year, and also give our other station W B U X two weeks notice of our cancelation of program. Motion passed and is to be ratified by Official Board of Highway Tabernacle.

Bro. MacPherson then read the minutes of the previous meeting and they were accepted as read, with a vote of thanks to our Bro. Bro. John Gerhart read the Treasurers report in the absence of Bro. Dron. Treasurers report was also accepted as read.

The Board of Trustees by common consent decided to send to the Ministers Conference in the Pocono Mts. Pastor and Sister Roberson, Bro. and Sister Waggner, Bro. and Sister McDowell and Ruth Muir. Total cost to be \$154.00 dollars. Conference to last two days.

George Ambrose mentioned about Bibles that Ruth Muir would like to have to give out to those who do not have one. Bro. Roberson to pick up the Bibles for her.

Bro. Roberson mentioned about a film that the young people had shown the previous Sunday night. The cost of the film was \$37.50 and they did not have enough in the Treasury to cover the cost. Bro. Griffith made a motion and seconded by Bro. Heintz that we pay the cost of the film. Motion passed.

A motion was made by Bro. John Gerhart and seconded by Bro. MacPherson that we give Willard Cantelon \$50.00 dollars a month towards his support in his European Campaign. Also Sister Roberson's class to take on Sonny Perna at \$ 35.00 dollars a month, which used to go to Pete Hunt and is now being with held at this time. Motion passed.

A motion was made by Thomas Griffith seconded by Fred Heintz that we give \$100.00 dollars to Teen Challenge to send Fred Frye to Bible School. This young man was wonderfully saved from a life of sin and has a wonderful testimony. Motion passed.

A motion to adjourn was accepted and the meeting was closed with prayer.
